

Bob's response to Carl's Birthright thesis below:

Carl presents sound reasoning in his attached thesis on birthright citizenship, and I stand shoulder to shoulder with him on this issue. His explanation to me of what natural-born citizenship really means brought clarity to my mind for the first time just a few weeks ago.

As some of you know, that was a major reversal for me, and very freeing as well. Please allow me, before you read his explanation, to make an introductory point of my own.

While studying recently I reread that poignant phrase in the Declaration of Independence which states that in order to secure our rights "*Governments are instituted among Men, deriving their just powers from the consent of the governed.*" It dawned on me at that instant that we could NEVER be rightly called citizens of the UNITED STATES, as that has never been a government "by consent of the governed".

My point is that said corporation may have a constitution, members, regulations, etc., but it can never have either citizens nor political jurisdiction. As Carl explains more clearly and thoroughly, we have been free all along.

The US corporation operates in fraud, by deceit and coercion, and we never have been citizens of it nor can we be reasonably classified as "Aliens", such as the current Naturalization Act falsely claims.

I suggest that we need only claim our freedom as fact and agree to be honest, upright citizens in our Free States. As you likely know, the "Declaration of Sovereign Right by Indigenous Power" accomplishes that quite handily.

Finally, there is no need to rush into accepting the new Act, although I don't see any chance of keeping that from happening. It will pass, and bring more confusion and trouble with it. If we would only learn to let these things marinate for a while until all concerns are settled.

Introduction

I have been concerned with a thesis put before us concerning those of us who are natural-born Americans. It is implied that we must go through a naturalization process which would allow us passage into the Republic. I wrote this short paper with definitions found in Bouvier's Law Dictionary in order to express my thoughts on why I believe asking natural-born heirs, with inherent rights in the Republic, to be naturalized is an oxymoron.

: The Republic of the united-states-of-America: Our-Birthright.

The Republic once created by the people through the ratification of the Constitution of the united-states-of-America stands until the people abolish the Republic. The Republic has never been abolished by the people. The Republic of the united-states-of-America lives in the life of the people today. Because the Republic is the only lawful-government of the united-states-of-America, all other claims on the people by any other government are unlawful and fraudulent.

The birthright-claim of the people in the Republic of the united-states-of-America is informed by the definition of the word-birthright in the Bouvier Law Dictionary of 1856.¹

birthright

BIRTH'RIGHT, n. [birth and right.] Any right or privilege, to which a person is entitled by birth, such as an estate descendible by law to an heir, or civil liberty under a free constitution. ¹

Esau, for a morsel, sold his birthright. Heb.12.

It may be used in the sense of primogeniture, or the privilege of the first born, but is applicable to any right which results from descent.

Civil liberty is the power to do whatever is permitted by the constitution of the state and the laws of the land. It is no other than natural liberty, so far restrained by human laws, and no further, operating equally upon all the citizens, as is necessary and expedient for the general advantage of the public. 1 Black. Com. 125; Paley's Mor. Phil. B. 6, c.5; Swifts Syst. 12.¹

Adhesion contracts seek to bind us to the de facto by the use of fraud. A lawful contract is offer, acceptance and fulfillment with full knowledge of the terms of the contract by both parties. We were not a willful-party to our birth-certificate-contracts, and all other adhesion contracts are perpetrated in fraud because we the people were not informed of the terms with full knowledge of the contract.

FRAUD, contracts, torts. Any trick or artifice employed by one person to induce another to fall into an error, or to detain him in it, so that he may make an agreement contrary to his interest.

Fraud avoids a contract, ab initio, both at law and in equity, whether the object be to deceive the public, or third persons, or one party's endeavor thereby to cheat the other.¹

Perhaps a better way of understanding how we the people in the Republic find ourselves is as prisoners of war held captive in a prison without walls bound by chains of fraud in our own land. Prisoners of war never become citizens of the country where they are held captive. The home country of the prisoners of war go into immediate action to bring those prisoners of war home and they are hailed as heroes when they arrive home. Those prisoners of war which are now freed of their captivity are certainly not asked to naturalize themselves into the country of their birth.

Were you like me when I discovered my captivity and realizing my plight, I began the freedom-journey. I joyfully joined others of my brothers and sisters who also had walked through the walls of a false prison and had cast off the chains of fraud and found themselves in the Republic of the united-states-of-America, in the land of our natural-birth. Together, by exercising

our constitutional rights, we began the formation of the lawful-government which was dissolved by way of fraud many years ago. Today, we have a government once again of the people, by the people, and for the people.

We have always been the republic because the republic is we the people. The republic has always been alive because we are alive. The republic is the birthright-claim of all natural-born people of the land we call America.

ALIEN, persons. One born out of the jurisdiction of the United States, who has not since been naturalized under their constitution and laws. To this there are some exceptions, as this children of the ministers of the United States in foreign courts.

NATURALIZE, v.t. [from natural, nature.]

1. To confer on an alien the rights and privileges of a native subject or citizen; to adopt foreigners into a nation or state, and place them in the condition of natural born subjects.

Based on the foregoing definitions, is it right that I inform the corporate government that fraudulently incorporated me and spelled my name in all capital letters (thereby signifying the creation of a corporation in my name) that I am by affidavit claiming this republic with my birthright? Yes! Emphatically!
