Dear Rep. Irwin,

Thank you for replying to my NOTICE, you are the only one that has addressed this very serious breach of our constitutional protection of rights that has been usurped by HLS. The NOTICE was sent to all of the Michigan Congress by email, postal mail, and was published in the Detroit Free Press under Announcements in print and online for a week.

I appreciate your taking the time to reply but I'm very disappointed, and disgusted with its content. This is not a Civil Liberties issue, this is a CONSTITUTIONAL PROTECTION ISSUE, and you along with ALL ELECTED officials took an OATH to support the Constitution and you are in office to REPRESENT THE PEOPLE and PROTECT OUR CONSTITUTIONAL RIGHTS.

It is not only your job, but your duty as well to defend the constitution which protects the rights of the people; this is first and foremost why you were ELECTED by the PEOPLE to the office you hold. You stated in your letter:

**“Unfortunately as a state representative I cannot directly influence federal policy.”**
